

## UBS Arena “50 Days Until Home Opener” Sweepstakes

The following terms and conditions (collectively, the "Terms and Conditions") shall apply to the UBS Arena “50 Days Until Home Opener” Sweepstakes (the "Sweepstakes").

**Eligibility: VOID WHERE PROHIBITED.** The Sweepstakes is open to legal residents of the United States (excluding residents of Puerto Rico, U.S. Virgin Islands, Guam and other United States territories) who are at least 18 years of age at the time of entry. All eligibility is further subject to all federal, state, and local laws and regulations. All entries submitted are the property of New York Arena Partners, LLC (the "Sponsor"). No purchase necessary to enter or win the Sweepstakes. A purchase will not increase or impact your chances of winning. Only one (1) entry per person is permitted during the Sweepstakes Period.

One (1) winner (“Winner”) will be selected in a random drawing containing all eligible entries received during the Sweepstakes Period. Drawing will take place on August 26, 2022. Sponsor's decision is based on its sole discretion and interpretation of these Terms and Conditions and is final and binding in all respects. - one (1) pair of tickets to a New York Islanders game at UBS Arena in October (the “Game”), exact game to be selected by Winner, subject to exclusions as determined by Sponsor in its sole discretion, seating location to be determined by Sponsor in its sole discretion;

- one (1) fifty-dollar (\$50) Belmont Hall gift card;
- two (2) posters of UBS Arena signed by New York Islanders player(s), exact player(s) to be determined by Sponsor in its sole discretion; and
- two (2) hockey sticks signed by New York Islanders player(s), exact player(s) to be determined by Sponsor in its sole discretion.

The Prize is subject to New York State guidelines and Winner and their guest must comply with all guidelines and rules for entry into UBS Arena, as may be applicable. Approximate retail value of the Prize: \$900.00.

The Winner will be notified on August 26, 2022 by 5:00 p.m. ET. The Winner agrees to be notified by Sponsor via either: (a) Instagram (if entered via Instagram), or (b) the mobile number and email address provided on the online entry form (if entered via AMOE). If the Winner is unreachable by August 29, 2022 at 5:00 p.m. ET, or if Winner is unavailable for the Prize, an alternate winner will be selected by the Sponsor. The Prize is nontransferable.
