

UBS Arena “Healthcare Heroes” Sweepstakes

The following terms and conditions (collectively, the "Official Rules") shall apply to UBS Arena “Healthcare Heroes” Sweepstakes ("Sweepstakes").

Eligibility: VOID WHERE PROHIBITED.

The person who submits the entry will be referred to as the "Entrant" or "Nominator". In order to participate by submitting an entry as a Nominator in the Sweepstakes, you must be a legal resident of the United States (excluding residents of Puerto Rico, U.S. Virgin Islands, Guam and other United States territories) who are at least 18 years of age at the time of entry. The person you nominate ("Nominee") must be a legal resident of the United States (excluding residents of Puerto Rico, U.S. Virgin Islands, Guam and other United States territories) who are at least 18 years of age at the time of entry and who is an eligible Healthcare Worker (as defined below) who is currently working as such or retired. A Nominator should have the Nominee's permission to nominate them in this Sweepstakes. All eligibility is further subject to all federal, state, and local laws and regulations. All entries submitted are the property of the New York Arena Partners, LLC (the "Sponsor"). No purchase necessary to enter or win the Sweepstakes. A purchase will not increase or impact your chances of winning. Employees of New York Arena Partners, LLC and its affiliates, and the immediate families and household members of such employees are not eligible to win.

How to Participate: The Sweepstakes period begins at 12:00 p.m. Eastern Time ("ET") on July 28, 2021 and ends at 10:00 p.m. ET on July 30, 2021 ("Sweepstakes Period"). During the Sweepstakes Period, visit the Sponsor's website, www.ubsarena.com/healthcareheros to nominate a deserving Healthcare Worker (as defined below), by properly completing and submitting the entry form, including a brief description (250 words or less) stating why you are nominating that individual.

Entry must be Entrant's own original work, be in English, and not be offensive or inappropriate, as determined by the Sponsor in its sole discretion. Entry cannot defame or invade publicity rights or privacy of any person, living or deceased, or otherwise infringe upon any person's personal or property rights or any other third-party rights. Entrants may not nominate themselves. Entrants may nominate more than one individual provided that each nomination is submitted separately. An Entrant may only nominate the same individual once. Multiple entries received from the same Entrant for the same Nominee will be void. Entries must be complete and provide authentic information to be eligible. By submitting any entry, you agree to be bound by these Official Rules. The odds of winning vary based on total number of eligible entries received. Eligible Healthcare Workers are any person who works in the medical or biomedical industry, manufacturer workers for health manufacturing parts, products and supplies, and the healthcare industry as a caregiver or otherwise.

Four (4) Nominees (each a “Winner” or “Winners”) will be selected in a random drawing containing all eligible entries received during the Sweepstakes Period. Drawing will take place on August 2, 2021. Winners will be required to provide a copy of healthcare employer-issued I.D. or other proof (in a form acceptable to Sponsor) of healthcare worker employment or volunteer status, or Prize will be forfeited. Sponsor's decision is based on its sole discretion and interpretation of these Official Rules and is final and binding in all respects. Each Winner will receive four (4) tickets (one (1) each for Winner, Winner’s guest, Entrant and Entrant’s guest) to the Sebastian Maniscalco show at UBS Arena on December 27, 2021 and dinner during a pre-show event at UBS Arena (the “Prize”). The Prize is subject to New York State guidelines and any all guests of UBS Arena must comply with all New York State guidelines for entry into the vaccinated section at UBS Arena, as may be applicable. Winners will be notified on August 2, 2021 by 5:00 p.m. If Winner is unreachable by August 3, 2021 at 5:00 p.m., or if Winner is unavailable for the Prize, an alternate winner will be selected by the Sponsor. Prize is nontransferable.

By claiming the Prize, the Winner authorizes the use, without additional compensation, of Winner’s name and/or likeness and/or voice/photograph and/or municipality of residence for promotion and/or advertising purposes in any manner and in any medium which the Sponsor may deem appropriate. Winner and all Entrants, as a condition of entry into the Sweepstakes, agree to release New York Arena Partners, LLC, and its affiliates from and against any and all

liability, claims or actions of any kind whatsoever for injuries (including as a result of the novel COVID-19 virus), damages, or losses to persons or property which may be sustained in connection with participating in any aspect of the Sweepstakes, the receipt, ownership or use of the Prize awarded, or any typographical or other error in these Official Rules.

The Sweepstakes is subject to all federal, state and local laws. The Sponsor reserves the right to withdraw, terminate or modify the Sweepstakes at any time without prior notice. Any federal, state and local taxes and expenses relating to the acceptance and use of the Prize are the sole responsibility of Winner. Void where prohibited by law.

The Sponsor is not responsible for technical, hardware, software or telephone malfunctions of any kind, lost or unavailable network connections, or failed, incorrect, incomplete, inaccurate, garbled or delayed electronic communications caused by the user or by any of the equipment or programming associated with or utilized in the Sweepstakes or by any human error which may occur in the processing of the entries in the Sweepstakes or for any liability for damage to any computer system resulting from participation in, accessing or downloading information in connection with the Sweepstakes.
