

UBS Arena “Eric Church Vaccine Clinic” Sweepstakes

The following terms and conditions (collectively, the "Official Rules") shall apply to the UBS Arena “Eric Church Vaccine Clinic” Sweepstakes ("Sweepstakes").

Eligibility: VOID WHERE PROHIBITED. The Sweepstakes is open to legal residents of the United States (excluding residents of Puerto Rico, U.S. Virgin Islands, Guam and other United States territories) who are at least 18 years of age at the time of entry. All eligibility is further subject to all federal, state, and local laws and regulations. All entries submitted are the property of the New York Arena Partners, LLC (the "Sponsor"). Only one (1) entry per person is permitted during the Sweepstakes Period.

By submitting any entry, you agree to be bound by these Official Rules. The odds of winning vary based on total number of eligible entries received. Entries that do not comply with these Official Rules will be disqualified.

Five (5) winners (each, a “Winner” or “Winners”) will be selected in a random drawing containing all eligible entries received during the Sweepstakes Period. Drawing will take place on August 30, 2021. Sponsor's decision is based on its sole discretion and interpretation of these Official Rules and is final and binding in all respects.
