

## UBS Arena's "UBS Arena Stevie Nicks Sweepstakes"

The following terms and conditions (collectively, the "Terms and Conditions") shall apply to the UBS Arena's "UBS Arena Stevie Nicks Sweepstakes" (the "Sweepstakes").

**Eligibility: VOID WHERE PROHIBITED.** The Sweepstakes is open to legal residents of the United States (excluding residents of Puerto Rico, U.S. Virgin Islands, Guam and other United States territories) who are at least 18 years of age at the time of entry.
