

**UBS Arena's "UBS Arena Professional Women's Hockey League March 25, 2024 Game Tickets Sweepstakes"**

The following terms and conditions (collectively, the "Terms and Conditions") shall apply to UBS Arena's "UBS Arena Professional Women's Hockey League March 25, 2024 Game Tickets Sweepstakes" (the "Sweepstakes").

**Eligibility: VOID WHERE PROHIBITED.** The Sweepstakes is open to legal residents of the United States (excluding residents of Puerto Rico, U.S. Virgin Islands, Guam and other United States territories) who are at least 18 years of age at the time of entry.
