

UBS Arena's "Ride the Long Island Rail Road" October 27, 2024 Sweepstakes

The following terms and conditions (collectively, the "Terms and Conditions") shall apply to UBS Arena's "Ride the Long Island Rail Road" October 27, 2024 Sweepstakes (the "Sweepstakes").

Eligibility: VOID WHERE PROHIBITED. The Sweepstakes is open to legal residents of the United States (excluding residents of Puerto Rico, U.S. Virgin Islands, Guam and other United States territories) who are at least 18 years of age at the time of entry. All eligibility is further subject to all federal, state, and local laws and regulations. All entries submitted are the property of New York Arena Partners, LLC, UBS Business Solutions US LLC ("UBS"), and Metropolitan Transportation Authority ("MTA") (collectively, the "Sponsor"). No purchase necessary to enter or win the Sweepstakes. A purchase will not increase or impact your chances of winning. Officers and directors of Sponsor, Employees of Sponsor, its affiliates, and the immediate families and household members of each are not eligible to win. Employees of the MTA, its affiliates, and the immediate families and household members of each are not eligible to win. How to Participate: The Sweepstakes period begins at 12:00 p.m. Eastern Time ("ET") on October 21, 2024, and ends at 7:00 p.m. ET on October 27, 2024 (the "Sweepstakes Period"). During the Sweepstakes Period, you may enter the Sweepstakes by: (a) accessing the MTA's TrainTime app to purchase your train ticket(s) and selecting the Elmont-UBS Arena destination (name of destination and "Zone" may vary) and by opting into the Sweepstakes when prompted to do so by agreeing to these Terms and Conditions, the Privacy Policy, and expressly consenting to receive emails concerning the Sweepstakes; or (b) submitting an AMOE (as defined below). Only one (1) total entry per person is permitted during the Sweepstakes Period. Only one (1) entry per person is permitted during the Sweepstakes Period. Only one (1) entry per transaction on the TrainTime app (regardless of how many train tickets are purchased) is permitted per Sweepstakes Period. Anyone found to submit multiple entries or use multiple e-mail, TrainTime app accounts or mobile numbers to enter will be ineligible.

Alternative Method of Entry ("AMOE"): On a plain 3" x 5" index card, legibly handprint or type your first name, last name, date of birth, complete address, city, state, zip code, home phone number (including area code), and email address, and mail your completed 3" x 5" card to New York Arena Partners, LLC, 2400 Hempstead Turnpike, Elmont, NY 11003, Attn: UBS Arena's "Ride the Long Island Rail Road" October 21, 2024. To be considered eligible in the Sweepstakes, AMOE entries must be received prior to October 21, 2024. Each AMOE card received that meets the requirements of these Official Rules will be considered as one (1) entry for that entrant.

Approximate retail value of each Prize: \$20. The Winners will be notified on October 21, 2024 (i.e., the date of the Event) at or about 7:00 p.m. ET. Each Winner agrees and expressly consents to be notified by Sponsor via SMS message to their mobile phone number (to the extent provided) or the email address provided on the online entry form or linked to their TrainTime app. Each Winner acknowledges and understands that message and data rates may apply. Each Winner also acknowledges and understands that they will only receive an email or SMS message (to the extent a telephone number is provided) with

a redemption code or QR Code if they are selected as a Winner, and any data rates or charges that may apply upon receipt of the redemption code or QR Code were not (and are not) a condition of entry for the Sweepstakes.

By claiming the Prize, the Winners authorize the use, without additional compensation, of Winners' name and/or likeness and/or municipality of residence for promotion and/or advertising purposes in any manner and in any medium which the Sponsor may deem appropriate.

Any federal, state and local taxes and expenses relating to the acceptance and use of the Prize are the sole responsibility of the Winners. Void where prohibited by law.
